Factsheet: The Belgian House of Representatives



1. At a glance

Belgium is a federal state with a federal Parliament consisting of two chambers, the House of Representatives (Kamer van volksvertegenwoordigers/Chambre des représentants) and the Senate (Senaat/Sénat). The regions (Flanders, Wallonia and Brussels) and the communities (Flemish, French-speaking and German-speaking) have their own elected assemblies.

The House's 150 representatives are directly elected under a proportional voting system from 11 electoral districts. Belgium has compulsory voting and thus maintains one of the highest rates of voter turnout in the world. The current Belgian government led by Prime Minister Charles Michel (MR/ALDE) is formed by a coalition of the Dutch-speaking parties N-VA (ECR), Open VLD (ALDE), CD&V (EPP) and the MR.

The Federal Advisory Committee for European Affairs is composed of 30 Members: 10 Members of the Senate, 10 Members of the House of Representatives and 10 Members of the European Parliament elected in Belgium.

4. Relations with Members of the European Parliament

Participation rights for Belgian MEPs in plenary sittings	No, in principle MEPs are not allowed to participate in a plenary meeting. However, there are precedents during which MEPs presented their report (drafted on behalf of the Federal Advisory Committee on European Affairs).
Participation rights for Belgian MEPs in committee meetings	In the Federal Advisory Committee for European Affairs, MEPs can take part in the debate and also vote, while in other Committees MEPs can only take part in the debate but not vote. The Chairperson of the Committee has to give them permission in advance.
